October 31, 2016 Minutes

The 565th meeting of the Board of Directors of the Kushla Water District was held at 4:00pm on Monday, October 31, 2016, at the Kushla Water District office, 6649 Highway 45, Eight Mile, Alabama.

CALL TO ORDER: The Chairman, William Silver, called the meeting to order at 4:00pm. - Regarding water pressure on Lafitte, Mr. Silver asked about reversing the impellers on the pumping station at Lafitte. After some discussion, Mr. Luker said he would look into it.
