TO THE HONORABLE L. W. NOONAN, JUDGE OF SAID PROBATE COURT:

Comes now the Kushla Water and Fire Protection District, a public corporation, by and through its Chairman of the Board and Secretary, and pursuant to the provisions of Title 11, Section 11-89-5 of the Code of Alabama of 1975, as last amended, and files this certificate and shows unto the Court as follows:

ONE:

The Kushla Water and Fire Protection District, a public corporation, was incorporated in Mobile County, Alabama, on the 27th day of March, 1974.

TWO:

That the Board of Directors of the said Kushla Water and Fire Protection District at the regular monthly meeting held on the 30th day of May, 1989, passed and approved a resolution proposing that Paragraph SEVEN of the Certificate of Incorporation be amended. A copy of said resolution, duly certified, is attached hereto as "Exhibit A".

THREE:

That the Board of Commissioners of Mobile County, Alabama, at the regular meeting held on the 23rd day of October, 1989, passed and adopted a resolution approving the proposed amendment of Paragraph SEVEN of the Certificate of Incorporation of the Kushla Water and Fire Protection District. A copy of the resolution adopted by the Board of Commissioners is attached hereto as "Exhibit B".

FOUR:

That the City Council of the City of Saraland, Alabama, the governing body of said municipality, at the regular meeting held on the 13th day of July, 1989, passed and adopted a resolution approving the proposed amendment of Paragraph SEVEN of the Certificate of Incorporation of the Kushla Water and Fire

Protection District. A copy of the resolution adopted by the Saraland City Council is attached hereto as "Exhibit C".

FIVE:

That the City Council of the City of Prichard, Alabama, the governing body of said municipality, at the regular meeting held on the 11th day of July, 1989, passed and adopted a resolution approving the proposed amendment of Paragraph SEVEN of the Certificate of Incorporation of the Kushla Water and Fire Protection District. A copy of the resolution adopted by the Prichard City Council is attached hereto as "Exhibit D".

SIX:

The Certificate of Incorporation of the Kushla Water and Fire Protection District shall be and hereby is amended in the following manner:

Paragraph SEVEN of the Certificate of Incorporation shall be deleted, and in lieu thereof, the following paragraph shall be substituted:

" SEVEN:

The Board of Directors of the KUSHLA WATER AND FIRE PROTECTION DISTRICT shall consist of EIGHT Directors. The places of each Director shall be numbered. The Directors for places One, Two, Three, Four, Five and Six shall be selected by the Honorable Board of Commissioners of Mobile County, Alabama. The Director for place Seven shall be selected by the governing body of the City of Saraland. The Director for place Eight shall be selected by the governing body of the City of Prichard. It is hereby stipulated that the places of the present Directors shall henceforth be places One through Five, and that the three new places shall be places Six, Seven and Eight. Each Director shall be a bona fide resident of the Kushla Water and Fire Protection District's service area and shall own real property within the service area. Each Director shall also be a qualified elector of Mobile County, Alabama, and in the event that the nominating authority for that Director is a municipality, that Director shall also be a qualified elector of such

municipality. "

RESOLUTION OF THE BOARD OF DIRECTORS

WHEREAS, this public corporation was incorporated under the provisions of Title 11, Sections 11-89-1, et seq., of the Code of Alabama of 1975, (formerly Title 50, Chapter 6, Section 99, et seq., of the Code of Alabama of 1940), and

WHEREAS, at the time of incorporation, the service area of the District was located primarily within the Kushla community of Mobile County, Alabama, and

WHEREAS, the service area of the District and the certificate of incorporation have twice been amended to add substantial new areas to the service area, and

WHEREAS, the five communities of Kushla, Smithtown-Oak Grove, Mauvilla, Chunchula and Kali-Oka are now included within the service area of the District, and

WHEREAS, as of the date of this resolution there are approximately 360 subscribers in the Kushla community, 125 subscribers in the Smithtown-Oak Grove community, 118 subscribers in the Mauvilla community, 195 subscribers in the Chunchula community, and 412 subscribers in the Kali-Oka community, and

WHEREAS, the Board of Directors of the Kushla Water and Fire Protection District is of the opinion that it would be in the best interest of the District that the membership of the Board of Directors more accurately represent the active subscriber usage per each community, and

WHEREAS, at the time of the incorporation of the District, no municipalities were located within the service area of the District, but now the municipalities of Prichard and Saraland are located within the service area of the District, and

WHEREAS, under the provisions of Title 11, Section 11-89-1, et. seq. of the Code of Alabama of 1975, the municipalities of Prichard and Saraland are entitled to appoint one Director to the Board of Directors, and

WHEREAS, the requirement that Directors reside within the service area of the District will by necessity under the existing

municipal boundaries and the existing District service area dictate that the Director selected by Saraland will be a resident of the Kali-Oka community and that the Director selected by Prichard will be a resident of the Kushla community, and

WHEREAS, the Board of Directors of the Kushla Water and Fire Protection District is of the opinion that it would be in the District's best interest if the Certificate of Incorporation and and By-Laws were amended to provide that the number of Directors that serve on the Board of Directors be increased from five to eight members to provide for better representation of all the communities located within the District's service area, and

WHEREAS, the Board of Directors is also of the opinion that the places of the Directors be numbered with the goal and intent of designating a place for each community located with the service area, and

WHEREAS, the Board of Directors is also of the opinion that the places, nominating authority and area to be represented by the respective Director should be established as follows:

Place One ---	Mobile County Commission ---	District-at-Large
Place Two ---	Mobile County Commission ---	Mauvilla
Place Three -	Mobile County Commission ---	Smithtown-Oak Grove
Place Four --	Mobile County Commission ---	Chunchula
Place Five --	Mobile County Commission ---	Kali-Oka
Place Six ---	Mobile County Commission ---	Kushla
Place Seven -	City of Saraland -----	Kali-Oka
Place Eight -	City of Prichard -----	Kushla

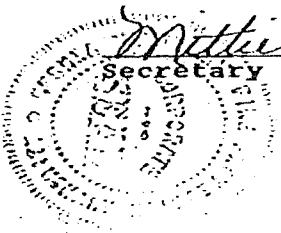
NOW THEREFORE, the Board of Directors of the Kushla Water and Fire Protection District, at this regular meeting of said Board held on this the 30th day of May, 1989, does hereby adopt the following resolution proposing that Paragraph SEVEN of the Certificate of Incorporation be amended so as to provide for the increase of the number of Directors from five to eight, the numbering of each place to be served by the Directors, and the appointment of at least one Director by the governing bodies of the City of Prichard and the City of Saraland, to-wit:

"BE IT HEREBY RESOLVED, that the Board of Directors of the Kushla Water and Fire Protection District, at the regular meeting held on the 30th day of May, 1989, does propose to amend the Certificate of Incorporation of the Kushla Water and Fire Protection District in the following manner: First, Paragraph SEVEN of the Certificate of Incorporation, as last amended, shall be deleted, and in lieu thereof, the following paragraph shall be substituted:

" SEVEN:

The Board of Directors of the KUSHLA WATER AND FIRE PROTECTION DISTRICT shall consist of EIGHT Directors. The places of each Director shall be numbered. The Directors for places One, Two, Three, Four, Five and Six shall be selected by the Honorable Board of Commissioners of Mobile County, Alabama. The Director for place Seven shall be selected by the governing body of the City of Saraland. The Director for place Eight shall be selected by the governing body of the City of Prichard. It is hereby stipulated that the places of the present Directors shall henceforth be places One through Five, and that the three new places shall be places Six, Seven and Eight. Each Director shall be a bona fide resident of the Kushla Water and Fire Protection District's service area and shall own real property within the service area. Each Director shall also be a qualified elector of Mobile County, Alabama, and in the event that the nominating authority for that Director is a municipality, that Director shall also be a qualified elector of such municipality."

The foregoing resolution was adopted by the Board of Directors of the Kushla Water and Fire Protection District at its regular meeting held on the 30th day of MAY, 1989.

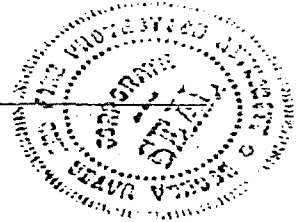




